Coming December 1, 2022: Announcement of Board Nominees and Petition Process

The affairs of the credit union are governed by nine Directors, as provided by the Generations Federal Credit Union bylaws. These officials are elected by and from the credit union's membership. Three (3) positions are up for election this year. Nominations have been received by the GFCU Governance Committee.

The slate of Nominees will be announced on December 1, 2022 at which time members interested in becoming a candidate for the Board of Directors may petition the credit union membership to request a position on the ballot.

The petition package will be available to download online on December 1, 2022, with email and website notifications sent to all members. Fully completed petition packages with signatures will be due on January 6, 2023. Learn more at <u>mygenfcu.org/about</u>.
