

#### **Letter from the President**



The entire Generations FCU family is excited to kick off a New Year with you, our valued members. Because of your support as a member, we're heading into 2023 with the momentum of new branch locations, more product and service offerings, and the move of our Headquarters to a new building at One Castle Hills. More details on that are coming very soon, and we can't wait to celebrate this milestone with you.

2022 was an incredible year, and we are so grateful for your continued commitment to the Generations team as your trusted financial partner. In November, we were announced as one of the top five organizations in the San Antonio Express-News 2022 Top Workplaces Awards in the mid-size employer category. Out of over 1,500 companies participating in the program, only 100 were recognized, and Generations was among only 25 other mid-size employers throughout the city.

In our continued commitment to serving first responders, our 10th Annual Turkey Express event allowed more than 50 team members to deliver Thanksgiving turkeys and hams to fire fighters throughout San Antonio, and hot Thanksgiving meals with sides and pies to police substations and county offices throughout our service area.

To further strengthen our community during this season of giving, our #GFCUCares team came together to raise over \$20,000 for the Leukemia Lymphoma Society's Light the Night Walk, which helps fund research and services related to the disease. We also partnered with Coats for Kidz to donate nearly 400 coats and jackets to help families in need keep their children warm during the winter months.

We were honored to continue our sponsorship of the Blue Santa Golf Tournament fundraiser presented by Blue Cares, the San Antonio Police Officers Association community outreach organization, to provide holiday gifts to children in low-income families. We've also sent teams to wrap gifts for Santa deliveries throughout the city. We supported the SA Food Bank's Harvest of Hope annual brunch fundraiser. Most recently, our teams have visited Boysville, Inc. to wrap hundreds of gifts donated by community members, making the holidays bright for foster children in residence ranging from under one year to 18 years of age.

#### **James Bell**

James W. Bell has been a Generations Federal Credit Union Member for 16 years. He has been an employee of a San Antonio area school district for 10 years. James currently serves as the CEO and one of the founding fathers of (L.I.T.T) "Life In The Tongue" nonprofit organization. He graduated from Sam Houston State University with a BS in Criminal Justice in 2004. He also furthered his education by obtaining a Master's in Computer Information Systems from University of Phoenix in 2010.



### Anthony Rogers, Ph.D.

Anthony "Tony" Rogers, Ph.D., previously served as GFCU Supervisory Committee Chair. As Fire Science Coordinator Instructor for the Fire Science Program for Northside Independent School District (NISD), Rogers manages dual college credit and certification programs for high school juniors and seniors. He serves as an Associate Professor at Texas A&M University (College Station) and Southern Illinois University, and is a 29 year veteran of the U.S. Navy and Marine Corps Reserve. Rogers has worked with municipal and educational organizations in Human Resources and Leadership management roles, and is a former Chair of the City of San Antonio Affirmative Action Committee. He holds a Bachelor of Business Degree from University of Texas at San Antonio, Master of Business Administration (MBA), and Doctorate of Philosophy from Our Lady of the Lake University in San Antonio, Texas.

James Smith currently serves as an Associate Board Member for the Generations Federal Credit Union Board of Directors. He is a Sergeant with the San Antonio Police Department, serving the department since 1992. James is also a Chairman on the San Antonio Fire & Police Pension Fund and has previously served as an Executive Board member of the San Antonio Police Officers Association (SAPOA). He currently serves as President of the Board of Directors for the Texas Association Public Employee Retirement Systems (TEXPERS). James also spent 11 years in the United States Army, departing as a captain.
